**Parent/Guardian Assumption of Risk and Waiver
and Release of Liability Relating to COVID-19**

I, _____, acknowledge that on or about March 11, 2020, novel coronavirus, COVID-19, was declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

While COVID-19 can cause mild symptoms in some individuals, it can lead to severe illness and even death in others. Adults over age 65 and people of any age with serious underlying medical conditions including, but not limited to, HIV, asthma and other respiratory conditions, and pregnancy, may be a higher risk for more serious complications from COVID-19.

I. Assumption of Risk. Boys and Girls Clubs of Bend (“BGCB”) will reopen on June 15, 2020 to provide essential services in the community. While BGCB has implemented preventative measures to reduce the spread of COVID-19, BGCB cannot guarantee that that I or my child(ren) will not become infected with COVID-19. I have read and understand the above warning concerning COVID-19. I knowingly acknowledge that by choosing to have my child(ren) participate in BGCB’s programs, and by entering BGCB’s premises, I risk exposing myself and my child(ren) to COVID-19 infection, which may result in serious illness, personal injury, permanent disability, and death. I understand the risk of becoming exposed to or infected by COVID-19 may result from the actions, negligence, and failure to act of myself and others, including, but not limited to, BGCB employees, and other program participants and parents. **I HEREBY CHOOSE TO ASSUME ALL OF THE FOREGOING RISKS**, and accept personal responsibility for any injury to myself or my child(ren) (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability or expense, of any kind of nature, that I or my child(ren) may suffer arising out of or in connection with my child(ren)’s participation in BGCB’s programs.

II. Waiver and Release of Liability. On my own behalf, on behalf of my child(ren), and the other members of my household, **I HEREBY FOREVER RELEASE AND WAIVE MY RIGHT TO BRING SUIT OR OTHER LEGAL ACTION** against BGCB, its employees, agents, managers, directors, officers, and representatives (“BGCB Parties”), and forever discharge the BGCB Parties, of and from all liabilities, claims, actions, damages, costs or expenses of any nature (“Claims”), whether known or unknown, foreseen or unforeseen, arising out of or in any way related to myself or my child(ren) becoming exposed to or infected by COVID-19 in connection with my child(ren)’s participation in BGCB’s programs. I understand that this release includes any Claims based on negligence, action or inaction of any of the BGCB Parties, and covers illness and bodily injury (including death) due to COVID-19, whether a COVID-19 infection occurs before, during or after my child(ren)’s participation in BGCB’s programs.

I have the legal right to consent to and, by signing below, **I HEREBY DO CONSENT TO THE TERMS AND CONDITIONS OF THIS WAIVER AND RELEASE** on behalf of myself, my child(ren), and the other members of my household.
